

2020 SCHOLARSHIP DESCRIPTIONS

John Ackerman Community Scholarship Fund

The John Ackerman Community Scholarship Fund was established on April 30, 2008 by Loretta Ackerman and Earl Bechtel. Recipients shall be recommended to the Foundation by the Fredericktown Community Foundation Selection Committee.

Aljian-Barnes Scholarship Fund

The Aljian-Barnes Scholarship Fund was established on December 22, 2009 by Deidre Aljian-Barnes and Greg Barnes. Students must be graduates of Fredericktown High School enrolled at an accredited college or university. Preference for students enrolling in M.D. program at Northeastern Ohio Universities College of Medicine. Secondary preference is for any M.D., D.O. or R.N. student, regardless of institution. Selection is based on merit and need may be considered if there are equally qualified candidates.

American Legion Post #136 Scholarship Fund

The American Legion Post #136 Scholarship Fund was established on April 8, 2010 by the Legion. Children, stepchildren or grandchildren of an active member of a Knox County veteran's organization are eligible. Selection is based on financial need and academic merit.

Robert C. Appleton Scholarship Fund

The Robert C. Appleton Scholarship Fund was established on January 28, 1980 with a distribution from Robert's will. The fund provides general scholarships, awarded on the basis of need and merit.

Arck-Crowthers Scholarship Fund

The Arck/Crowthers Scholarship Fund was created in 1992 in memory of Chris Arck and Mike Crowthers, two East Knox students who died from cancer while still in high school. Scholarships are provided to East Knox graduates on the basis of merit.

Paul J. Arnold Chemistry Scholarship Fund

Created June 17, 2016 in memory of Paul J. Arnold with contributions from family and friends. The purpose is to provide scholarship for MVHS gradates using the following criteria: Must be graduating senior from MVHS or MVHS Alumnus currently enrolled in college Excellence in study of advanced chemistry while enrolled as a student at MVHS Intention to study Chemistry, chemistry education, or chemical engineering at the undergraduate level. Recommended by MVHS Advanced Chemistry teacher. In the event there is no recommendation, the Selection Committee shall recommend a scholar from the MVHS application pool who meet the above criteria.

Chief Thomas E. Bartlett Scholarship Fund

The Chief Thomas E. Bartlett Scholarship Fund was established on July 26, 2006 with a \$5,000 contribution from Candis L. Bartlett. Scholarships are awarded to graduates of Mount Vernon High School or the Knox County Career Center based on financial need and pursuit of a career in law enforcement.

Dr. Allan Bazzoli Family Medical School Scholarship Fund

The Dr. Allan Bazzoli Family Medical School Scholarship Fund is funded through the Bazzoli Family Donor Advised Fund. Students must be enrolled in an Ohio medical school, have evidence of community service, and submit the FAFSA Student Aid Report (SAR).

Elizabeth W. Bell Scholarship Fund

The Elizabeth W. Bell Scholarship Fund was established July 22, 2005 with a \$10,000 contribution from Gretchen A. Bell. Scholarships are awarded to graduating seniors on the basis of financial need and who are in pursuit of a career in elementary education. The scholarship is renewable for three additional years, contingent upon the honoree's maintenance of full-time student status is good standing.

Clark and Lucy Biggs Scholarship Fund

Clark and Lucy Biggs Scholarship Fund was created in 1991 with a \$172,000 testamentary gift from G. Clark Biggs. The fund provides general Scholarships to Knox County students.

Blizzard Family Scholarship Fund

The Donald T. and Carolyn A. Blizzard Fund was created December 18, 2009 with a contribution of \$10,000 from Donald and Carolyn. The donors may advise the Foundation to make distributions to qualified charitable organizations. In the event there are no living advisors or continuing distribution advice in effect, fund assets will be transferred to an unrestricted fund, named in honor of the donors. When requested by the donor, general Scholarships are provided to Knox County students.

Donald T. Blizzard Engineering Scholarship

The Donald T. and Carolyn A. Blizzard Fund was created December 22, 2017 with a stock contribution from Carolyn. The fund provides scholarships to Mount Vernon High School graduates majoring in engineering. Students must currently be in Freshman or higher standing.

Boucher Family Fund

The Boucher Family Fund was established on August 7, 2014. The fund provides general scholarships to Knox County students.

Karl W. Brown Writing Award Scholarship Fund

The Karl W. Brown Writing Award was created in 2003 with memorial contributions totaling \$5,754 in the name of Karl W. Brown. The scholarship is granted upon recommendation by the English Department of Fredericktown High School for a senior whose collective body of written works and future potential in writing excellence is deemed most outstanding.

Holli Anne Bunnell Memorial Scholarship Fund

The Holli Anne Bunnell Scholarship Fund was created May 11, 2015 with memorial contributions totaling \$3,750 in Holli's name. Scholarships are awarded to graduating high school seniors or former graduates whose permanent residence is within Knox, Richland, or Morrow county and have a physician-confirmed diagnosis of epilepsy or other seizure disorder.

William Burgett Builder & Contractor Scholarship Fund

On Father's Day 2011, the children, grandchildren, and great-grandchildren of William B Burgett created the The William Burgett Builder & Contractor Scholarship Fund to provide annual \$1,000 scholarships to a graduate of Northmore or Fredericktown High Schools advancing his or her education in: 1st the construction field or 2nd the engineering field. Scholarships are recommended by Fredericktown and Northmor guidance offices.

Phil Burghard Memorial Scholarship Fund

The Phil Burghard Memorial Scholarship Fund was created on May 27, 2004 with memorial contributions totaling \$10,973.60. The Scholarship is awarded to a student who has been active as a varsity athlete at Highland High School, and who will be enrolled in an accredited post-secondary technical school, with preference to students pursuing the building trades. Ideally, the award should be made to students who possess exemplary personal qualities and positive attitudes, as did the scholarship's namesake, a member of the Highland High School Class of 1987.

Charles E. Cassady Scholarship Fund

The Charles E. Cassaday Scholarship Fund was created in 1990 through \$1,800 of memorial contributions. The fund is to provide general scholarships to Knox County Students.

Arthur and Joan Cassell Scholarship Fund

The Arthur and Joan Cassell Scholarship Fund was established on November 13, 2013 with a \$5,000 gift from the Arthur in memory of long time educator, Joan Cassell. Scholarships are provided to graduating seniors of East Knox High School.

Helen Hope Cooke Scholarship Fund

The Helen H. Cooke Scholarship Fund was created in 1994 with a \$650,000 gift from the Helen H. Cooke Living Trust. The fund provides general scholarships to graduates of Fredericktown High School.

Harold B "Cookie" Cunningham Scholarship Fund

The Harold B "Cookie" Cunningham Scholarship Fund was established on October 30, 1996 with a contribution from Bernice R. Cunningham. Scholarships are awarded to student athletes from Mount Vernon High School.

Norma J Cornell Memorial Fund

The Norma J Cornell Memorial Fund was created with a gift from Norma's estate. The fund provides scholarships for elementary, middle school, high school, college, or trade school education, including payment to or on behalf of someone in need of tuition for such education.

E. Allen Craigo Scholarship Fund

The E. Allen Craigo Scholarship Fund was established January13, 2016 with a contribution of \$16,666 from Jacqueline L. Craigo and a match of \$8,333 from the Ariel Corporation New Philanthropy Fund. Scholarships are provided to graduates of Mount Vernon High School attending a credited college or university to study science or mathematics and are based on merit.

Robert & Mary Crise First Congregational U.C.C. Scholarship

The Robert & Mary Crise First Congregational U.C.C. Scholarsihp Fund was created on December 7, 2017 with contributions of \$20,500.59 made in honor of Mary by her husband, Robert Crise, and a matching \$10,250 grant from the Ariel New Philanthropy Fund. The fund awards scholarships to graduating seniors or current college students who regularly attend First Congregational U.C.C. in Mount Vernon, OH (having at least 50% attendance at Sunday Services). Scholarships are awarded based on academic merit and students are selected by the Foundation's scholarship committee. Due consideration is given to applicants whose enrollment at a non-local college or university precludes strict compliance with the church attendance criterion.

Crise Family Scholarship Fund

The Crise Family Scholarship Fund was established on May 16, 2018 by Robert Crise. The fund provides scholarships for graduates of Danville High School.

Jason and Heidi Crowl Centerburg High School Alumni Scholarship Fund

The Jason and Heidi Crowl Centerburg High School Alumni Scholarship Fund was established on July 22, 2015 with a \$10,000 gift from the Crowls and a matching \$5,000 gift from the Ariel Corporation New Philanthropy Fund. Scholarships are given to students recommended by the Centerburg High School Alumni Association, according to criteria the Association may establish and revise from time to time.

Mike Crouch Memorial Scholarship Fund

The Mike Crouch Memorial Scholarship Fund was created on July 2, 2018 by Ellen Crouch, Mike's spouse, and donations through a memorial golf tournament. The scholarship provides a scholarship of at least \$1,000, renewable for four years, to a graduating senior of Mount Vernon High School who received a varsity letter in at least one sport, has a GPA of 3.5 (and maintains a post-secondary 3.0 GPA), and has evidence of financial need.

Henry L. and Alice H. Curtis Scholarship Fund

Established on September 14, 2014, the Henry L and Alice H Curtis Scholarship Fund provides scholarships to Knox County students at the discretion of the Board of Directors.

Ohio Lodge #199 F&AM Scholarship Fund

The Ohio Lodge #199 F&AM Danville Masonic Lodge F&AM Scholarship Fund was established January 16, 2003 with a \$30,000 contribution from the former Danville Masonic Lodge 546 through the Ohio Lodge #199. Two scholarships are awarded equally to students from the Danville and East Knox Local School Districts.

Daughters of the American Revolution, Lucy Knox Chapter, Frances Sturtevant Scholarship Fund

The Daughters of the American Revolution, Lucy Knox Chapter, Frances Sturtevant Scholarship Fund was created on February 23, 2011 with a contribution of \$5,000 from the Lucy Knox Chapter, D.A.R. Eligibility is limited to students pursuing post-secondary education at an accredited institution, who are natural or adopted children, grandchildren, great-grandchildren, etc. of living or deceased members of the Lucy Knox Chapter, D.A.R. Selection is based solely on academic merit.

Geraldine "Jerri" Dennis Memorial Scholarship

The Geraldine "Jerri" Dennis Memorial Scholarship was created March 16, 2010 and recognizes academic achievement by a Mount Vernon High School graduating senior.

Martha Deppner Scholarship Fund

The Martha Deppner Scholarship Fund was established January 18, 2006 with a \$8,000 contribution from Martha. Scholarships are awarded to graduates of Danville High School based on academic performance and financial need for students attending at a two-year or four-year college or university. Preference is given to students pursuing agricultural studies.

Gary & Carol Didinger Scholarship Fund

The Gary & Carol Didinger Scholarship Fund was created on December 31, 2006 with an initial gift of \$100,000. Scholarships are provided to students living in the Danville and East Knox Local School Districts and are pursuing the study of agriculture. Preference is given to students demonstrating both financial need and involvement in their respective communities.

Doris Jean Dilts Scholarship Fund

The Doris Jean Dilts Scholarship Fund was established on June 1, 2015 in memory of Doris. The fund provides scholarships to Fredericktown seniors with a 3.0 GPA and who have been in Vocational Agriculture for at least one year. A preference is given to students who plan to attend Mount Vernon Nazarene University.

Joe Divelbiss Memorial Scholarship

The Joe Divelbiss Memorial Scholarship established on February 1, 2007 with a contribution from Jennifer D. Parker et.al. Scholarships are awarded to graduating seniors from Fredericktown High School with demonstrated financial need and exceptional character.

Beverly Jo Dremann Education Scholarship Fund

The Beverly Jo Dremann Early Childhood Education Scholarship Fund was created on January 4, 2010 by Arthur K Dremann with an initial gift of \$5,500. Scholarships are given to graduates of Fredericktown High School pursuing a degree in education. Selection is based on academic merit, with financial need being a secondary criterion. The Fredericktown Community Foundation makes recommendations to the Foundation.

Robert Dusthimer Scholarship Fund

The Robert Dusthimer Scholarship Fund was established on August 25, 2015 with a contribution of \$12,250.70 from Wroena Dusthimer and a matching grant of \$6,125.35 from the Ariel New Philanthropy Fund. Scholarships are awarded to graduates of Danville High School with preference given to candidates pursuing a career in either the medical sciences (1st) or English (2nd) or Fine Arts (3rd).

Gary's Eagles Fund

Gary's Eagles Fund was established on December 27, 2016 by Marilyn Mansell and provides scholarships for Central Ohio Eagle Scout students in good standing, having passed the Boy Scout Board of Review, to further their education at an accredited college, university, or technical school. Students must be either a graduating high school senior or undergraduate college student with a GPA of at least 2.5 and consideration will also be given to the student's financial need. The applicant should be from Knox, Delaware, or Franklin counties and show demonstrated leadership ability in scouting as well as participate in activities outside of scouting.

Lori Emma's Earthly Angels Scholarship Fund

The Lori Emma's Earthly Angels Scholarship Fund was established 1/11/17 by Karen K and Jeffrey C Balcom for the purpose of providing scholarship assistance to prospective registered nursing students who are graduates of MVHS or KCCC. Fund is eligible for 50% matching grant from the New Philanthropy Fund. The initial gift and matching grant must remain non-distributable in perpetuity.

East Knox Community Scholarship Fund

The East Knox Community Scholarship Fund was established on January 15, 2010 by the East Knox Academic Booster Club with an initial gift of \$3,067.50. Scholarships are given to graduates of East Knox High School on the basis of demonstrated financial need and academic merit.

Mount Vernon Elks Lodge #140 Fund

The Mount Vernon Elks Lodge #140 Fund was created June 8, 2004 with a contribution of \$9,759.36. Scholarships are provided to Knox County students through the recommendation of the Lodge.

Marjorie Fearn Music Scholarship Fund

The Marjorie Fearn Music Scholarship Fund was created in 2008 with a \$15,153 interfund transfer from the Fredericktown Community Fund. Scholarships are provided to students chosen by the designated fund committee.

Fredericktown High School Student-Athlete Scholarship Fund

The Fredericktown High School Student-Athlete Scholarship Fund was established on February 14, 2017 by David and Joan Logan with an initial gift of \$5,000. The fund provides scholarships for Fredericktown High School students attending a qualifying post-secondary institution and participating in collegiate level athletics without benefit of athletic-designated assistance. The second priority is given to students who participated in at least one full season on the varsity basketball team. The third priority is given to students are recommended by the Foundation scholarship selection committee and awarded to one male and one female.

Ralph and Ara Flack Scholarship Fund

The Ralph and Ara Flack Scholarship Fund was created on May 17, 2000 by Mrs. Ara Flack with an initial gift of \$25,000. Scholarships are awarded to students living in the East Knox School District, regardless of the high school from which they graduate, who attend a technical school in Ohio. The East Knox High School Guidance Office recommends a student for this award.

Patricia & Robert Folland Scholarship Fund

The Patricia & Robert Folland Scholarship Fund was created August 14, 2014 with a \$50,000 contribution from Robert Folland and a matching \$25,000 grant from the Ariel New Philanthropy Fund. Scholarships are awarded to a graduating high school senior or undergraduate college student entering their sophomore, junior, or senior year of college. -At least one scholarship benefitting a Fredericktown High School graduate pursuing a degree in Education -At least one scholarship benefitting a graduate of any Knox County High School pursuing a degree in Education -At least one scholarship benefitting a graduate of any high school pursuing a degree in Law Enforcement or Pre-Law

Fredericktown Community Scholarship Fund

A scholarship is awarded to an engineering student at any four-year engineering college who shall be in his or her sophomore or later year, thereafter so long as the recipient maintains satisfactory grades and remains in engineering school. The basis for this award shall be financial need, merit regarding high school accomplishments, and merit regarding college accomplishments.

Knox County Foundation General Scholarship Fund

The fund awards scholarships to graduating seniors of a Knox County High School with a GPA of at least 3.5, who participated in Varsity sports for at least one year, and a qualifying essay addressing the value of athletic participation in the student's academic career to date, and his/his future endeavors.

Pauline L Gordon Memorial Scholarship

The Pauline L Gordon Memorial Scholarship was established on May 6, 2007 with a \$20,000 contribution from Jack and Emily Gordon. Scholarships are awarded to students based upon academic merit, by recommendation of the MVHS Guidance office. Preference is given to candidates pursuing a career in elementary education (kindergarten through sixth grade).

Robert J. and Arlene K. Griffith Centerburg H.S. Alumni Association Scholarship Fund

The Robert J. and Arlene K. Griffith Centerburg H.S. Alumni Association Scholarship Fund was created December 22, 2016 with a \$10,000 contribution from Robert and Arlene and a \$5,000 matching grant from the Ariel New Philanthropy Fund. Scholarships are given to students recommended by the Centerburg High School Alumni Association, according to criteria the Association may establish and revise from time to time.

Lillian C. Hickman Scholarship Fund

The Lillian C. Hickman Scholarship Fund was created in 1996 through Lillian's Last Will and Testament. Scholarships are awarded to Knox County college students, particularly undergraduate and graduate medical or premedical students interested in family practice or in cases where no such students qualify, then to other qualifying students in other areas of study.

Deborah Hillier Dwyer Memorial Scholarship Fund

The Deborah Hillier Dwyer Memorial Scholarship Fund was created in August 2017 by Sue Hillier in the name of her daughter with contributions from her estate as well as family and friends. The purpose of the fund is to provide scholarships for Knox County graduates who are a nursing major training to be an RN.

Carl E. & Sharon K. Holmes Scholarship Fund

The Carl E. and Sharon K. Holmes Scholarship Fund was created on December 31, 2018. Scholarships are awarded to Knox County students based on need.

Dr. John D & Norma L Hubbell Centerburg High School Alumni Scholarship Fund

The Dr. John D & Norma L Hubbell Centerburg High School Alumni Scholarship Fund was established on December 29th, 2015 with a \$10,000 gift from Mr. and Mrs. Hubbell and a \$5,000 matching Ariel Corporation New Philanthropy match. Scholarships are provided to graduating seniors from Centerburg High School and are nominated by the Centerburg High School Alumni Club.

William S. Hunter Scholarship Fund

The William S. Hunter Scholarship Fund was created December 27, 1990 with a \$6,000 contribution from Dr. William Hunter. Scholarships are awarded to Centerburg High School students with demonstrated financial need and academic performance.

Cody L. Johnson Memorial Scholarship Fund

The Cody L. Johnson Memorial Scholarship Fund was established on December 31, 2003 with various contributions. Scholarships are awarded to graduates of the Knox County Career Center from the Danville Local School District. Awardees must also completed the Career Center's ciriculum in either auto technology, auto body, or metal fabrication. If there are no such candidates from Danville Local Schools, the award may be given to a deserving graduate of one of these programs from any Knox County school district.

Edwin Kaylor Scholarship Fund

The Edwin Kaylor Scholarship Fund was established on February 28, 2005 with a cash contribution of \$100,481.93 via the Daville Local School District in accordance with the Last Will and Testament of Thomas E. Kaylor. Scholarships are awarded to deserving graduates recommended by the Danville Local Schools' Scholarship Committee for attendance at any state-supported college, university, or community college.

Josie Lynne Kaylor Memorial Scholarship Fund

The Josie Lynne Kaylor Memorial Scholarship Fund was established on June 5, 2016. It is restricted to graduating seniors of, and recent graduates of, Danville High School, who will be enrolled at an accredited two-year or four-year institution. An essay addressing how you have left a positive impact on your community and how you intend to do so in the community of your future college/university is required.

Harry and Marguerite Kaylor Scholarship Fund

The Harry and Marguerite Kaylor Scholarship Fund was established on December 31, 2015 through a \$10,000 testamentary gift under the Marguerite Kaylor Trust. Two educational scholarships in the amount of \$500 each are to be given each year until the fund is consumed. Financial need is the primary factor for consideration of candidates.

Josie Lynne Kaylor Memorial Nursing Scholarship Fund

The Josie L. Kaylor Memorial Nursing Scholarship Fund was created on May 30, 2013 in memory of Josie, who perished in a car accident on May 29, 2013 at the age of 19. Scholarships are awarded to Danville graduates pursuing a healthcare-related major. An essay addressing the importance of organ and tissue donation donor registration is required.

Knox County Fraternal Order of Police Lodge #147 James Barnett Memorial Scholarship Fund

The Knox County Fraternal Order of Police Scholarship Fund was established on April 24, 2003 with a cash contribution of \$1,500 from the Knox County FOP, Lodge #147. Scholarships are awarded to children of members of the FOP who have been in good standing for two years. Students must have a GPA of at least 2.7. Awards are in the amount of \$700.

Ryan Kelly Knox County Career Center Scholarship Fund

The Ryan Kelly Knox County Career Center Scholarship Fund was created on December 31, 2018 by Richard E. and Linda K. McCluskey. The scholarship is awarded to students who have completed at least one year of post-secondary study subsequent to his or her attendance at the Knox County Career Center. Scholarship is based on academic merit, however demonstrated financial need may be considered to differentiate between candidates of equivalent merit.

Raymond E. Kinney Scholarship Fund

The Raymond E. Kinney Scholarship was established on February 28, 2012 by his parents, Lewis P. and Georgeann Kinney. Scholarships are awarded to a graduating senior of a Knox County school pursuing a paramedic certification. Selection is based primarily on financial need and secondarily on academic achievement. In any year when no prospective paramedic students apply, the scholarship may be awarded to a graduating senior from Fredericktown High School, Centerburg High School, or the Knox County Career Center pursuing a registered nursing degree.

The Kiwianis Club of Mount Vernon Scholarship Fund was created May 4, 2017 with a \$8,714 contribution from the Mount Vernon Kiwanis Club . Scholarships are given to students recommended by the Key Club faculty advisors, according to criteria established within the fund documents.

Valjean & Charles "Tobe" Knerr Scholarship Fund

This Fund was created on September 4, 2019 with an contribution from Leslie Knerr Seibert. Distributed of income to be made to graduations seniors or prior year graduates of Mount Vernon High School. Prior year recipients are eligible to apply for scholarships from the Fund in successive years. Applicants will be evaluated equally on the basis of financial need and academic merit. The Selections Committee may consider applicants for four-year, two-year, or trade certification programs with an interest in supporting students pursuing degrees in education. Fund income permitting, the Donor requests at least one "substantial scholarship" to be awarded annually and also consider smaller awards for two-year and trade certificates.

The fund was established to proved scholarships for Knox County high school seniors or undergraduate students pursing a degree in music or veterinary science at an accredited school. Additional criteria include achieving at least a 3.5 GPA. Preference for a HS senior, but the recipient may be a current traditional or non-traditional college student.

Rex M., Jr. and Barbara C. Lamb Scholarship Fund

The Rex M., Jr. and Barbara C. Lamb Scholarship Fund was created on March 14, 1985 with a contribution of 400 shares of stock from Barbara in memory of her husband, Rex. The fund provides scholarships for the undergraduate education of worthy students in Knox County.

John D. and Mary Ann Lambert Centerburg High School Alumni Association Scholarship Fund

The John D. and Mary Ann Lambert Centerburg High School Alumni Association Scholarship was created July 10, 2015 with a \$10,000 contribution from John and Mary Ann and a \$5,000 matching grant from the Ariel New Philanthropy Fund. Scholarships are given to students recommended by the Centerburg High School Alumni Association, according to criteria the Association may establish and revise from time to time.

Harriett B. Lawler Memorial Scholarship Fund

The Harriett B. Lawler Memorial Scholarship Fund was established on May 6, 1986 with a distribution through Harriett's will. The fund provides general scholarships for Knox County students.

Charles Lawson Memorial Scholarship Fund

The Charles Lawson Memorial Scholarship Fund was established on October 4, 2013. The scholarship is awarded to one student graduating from Mount Vernon High School and who plans to participate in a college orchestra for the entire year. The \$1,000 scholarship will be held until the completion of the freshman year and then paid for the sophomore year. The student must have played a stringed instrument in high school and participate in college orchestra for an entire school year. The student does not need to be a music major and is nominated by the high school orchestra director.

Ruth Leedy Scholarship Fund

The Ruth Leedy Scholarship Fund was created February 21, 2006 with a contribution from the Ruth Leedy Estate of \$89,752.67 to assist graduates of Fredericktown High School. Awards will begin after the depletion of the Leedy Family Scholarship Fund.

John M. Lee Scholarship Fund

The John M. Lee Scholarship Fund was created on April 17, 2002 with a contribution from Carole A. Lee. Scholarships are awarded to graduating seniors in the automotive technology program planning to further his or her education, with preference given to those pursuing an associate degree. Students are recommended by the automotive technology instructor and the Superintendent at KCCC.

Alexandra D. Letz Scholarship Fund

The Alexandra D. Letz Scholarship Fund was established on April 19, 1983 with a \$10,000 contribution from Alexandra. The fund provides scholarships to Mount Vernon High School Graduates.

Alexandra D Letz Nursing Scholarship Fund

The Alexandra Letz Nursing Scholarship Fund was established on June 30, 1984 with a \$10,000 contribution from Alexandra. Scholarships are awarded to students studying to become registered nurses.

Kathryn Ann Levering Memorial Scholarship Fund

The Kathryn Ann Levering Memorial Scholarship Fund was established in March 2001 with a contribution from Kenneth and Suzanne Levering. Scholarships are for students who either are experiencing, or has experienced, cancer personally or within his or her immediate family (parents and siblings). Award is based on a 500-word essay regarding the applicant's fight, or their family's fight, with cancer. Students are recommended by Ken and Suzanne Levering and a Community Foundation committee member.

W. Joan Levering Scholarship Fund

Scholarships are awarded to students with demonstrated financial need, who will be pursuing a degree in one of the following disciplines: business administration, health services administration or management, nursing, physical therapy, occupational therapy or speech therapy.

Gerald D. & Barbara W. Lindstrom East Knox Scholarship Fund

Created April 16, 2018 to provided scholarships for for East Knox High School students, the Gerald D. and Barbara W. Lindstrom East Knox Scholarship Fund provides scholarships to either East Knox High School senior or undergraduate college students. Evidence of financial need is required. "It is the hope of the Donors that in your life you will choose to give back to society in some form of community service. "

Perkins-Owens Centerburg High School Alumni Association Scholarship Fund

The Perkins Owens CHS Alumni Association Scholarship Fund was created on May 16, 2018. The fund provides scholarships to Centerburg High School graduating seniors or senior high school or undergraduate college students enrolled in an accredited school. Criteria is established by the Centerburg Alumni Association.

The Arthur and Barbara Packard Memorial Fund

The Arthur J. Packard, Jr. Memorial Scholarship was created in 1992 via memorial contributions in the name of Art Packard. The fund provides scholarships to Mount Vernon High School graduates.

The Pay-it-Forward Centerburg Scholarship Fund is funded by previous scholarship recipients from Centerburg. Scholarships are provided to Centerburg graduates.

Pay-it-Forward Danville Scholarship Fund

The Pay-it-Forward Danville Scholarship Fund is funded by previous scholarship recipients from Danville. Scholarships are provided to Danville graduates.

Pay-it-Forward East Knox Scholarship Fund

The Pay-it-Forward East Knox Scholarship Fund is funded by previous scholarship recipients from East Knox. Scholarships are provided to East Knox graduates.

Pay-It-Forward Fredericktown Scholarship Fund

The Pay-it-Forward Mount Vernon Scholarship Fund is funded by previous scholarship recipients from Fredericktown. Scholarships are provided to Fredericktown graduates.

William and Helen Pond Scholarship Fund

The William and Helen Pond Scholarship Fund was established in 1996 witha \$10,000 contribution from Helen and \$330 in memorial contributions in the name of William. The fund provides scholarships to Mount Vernon High School Graduates.

Sarah Karolin Pressler Memorial Scholarship Fund

The Sarah Karolin Pressler Memorial Scholarship Fund was established in November 2002 with a contribution from David A. Pressler. Scholarships are awarded to students from Mount Vernon High School who have participated in the performing arts, including dance, music, and theater. Scholarships are awarded to Mount Vernon High School graduates and are based on financial need and academic merit to students who will be enrolled at an accredited college or university. Preference is given to those who plan to attend The University of Toledo, Ohio.

Justin T. Richert Scholarship Fund

The Justin T. Richert Scholarship Fund was created August 4, 2010. The fund provides scholarships to Mount Vernon High School graduates. Selection criteria, in the following order of importance, participated in the MVHS interscholastic golf program, exemplary sportsmanship, and academic performance.

Alan and Ruby Riedel Scholarship

The Ruby and Alan Riedel Fund was established in 2003 with an initial contribution of \$5,000 from Alan and Ruby. The donors may advise the Foundation to make distributions to qualified charitable organizations of their choice. Upon the death or incapacity of both Ruby and Alan, the fund will become a designated fun to encourage and stimulate civic improvements in Mount Vernon. Scholarships are provided to students attending Ohio University.

Pauline S. Riel Scholarship Fund

The Pauline S. Riel Scholarship Fund was established in October 2003. Scholarships are awarded to residents of Knox or Morrow Counties who have graduated from Highland, Mount Gilead or Mount Vernon High Schools and are pursuing a career in education. Candidates must demonstrate financial need as well as scholastic achievement or promise, combined with a record of participation in school, personal, or community activities. Students are recommended by a family member based on nominations from each of the qualifying school systems.

Mary Catherine Ritter Scholarship Fund

The Mary Catherine Ritter Scholarship Fund was created December 30, 2004. Scholarships are awarded to Mount Vernon High School graduating seniors pursuing careers in teaching, preferably in the field of foreign languages.

The Roelofs Family Scholarship Fund

The Roelofs Family Scholarship Fund was created on December 29, 2005 by a \$5,000 donation from Kemp Owyne Roelofs. Scholarships are provided to Mount Vernon High School graudates showing significant financial need.

Hugh Cameron Roelofs Scholarship Fund

The Hugh Cameron Roelofs Scholarship Fund was created on December 29, 2005 by a \$10,000 donation from Kemp Owyne Roelofs. Scholarships are provided to Mount Vernon High School graudates showing significant financial need.

William S. and Pearlene E. Rowley Scholarship Fund

Scholarship criteria include athletic and academic achievement, and school and community involvement. Candidates are recommended by the principal of Mount Vernon High School, the athletic director, the guidance counselor, and a member of the immediate family of Rick L. Scott, et al.

Bladensburg Sertoma Fund

This agreement was made on June 26, 2019 by the Bladensburg Sertoma Club with an establishing gift of \$12,500. The purpose is to provide scholarships to Bladensburg Community students attending an accredited college or university. The scholarship is to be awarded annually to students whose permanent residence is within the Bladensburg Community and within the East Knox School District (or any other successor school district), residing south of (or on) State Route 229, and those within the North Fork School District (or any other successor school district), residing in Knox County. Scholarship is awarded on the basis of both financial need and academic merit.

Gregory A. Shannon Memorial Scholarship Fund

The Gregory A. Preference will be given to students with demonstrated financial need. Recipients will be recommended by the Guidance Department of Mount Vernon High School.

Charles F. and Zella Horn Simpson Memorial Scholarship Fund

The Charles F. and Zella Horn Simpson Memorial Scholarship Fund was created on June 6, 1999 with a gift of \$42,394.09 through the Will of Doris O. Simpson. Scholarships are awarded to Knox County High School students attending Denison University, Wooster College, Kenyon College or Muskingum College, with preference given to those attending Denison University.

Sims-Rose Scholarship Fund

The Sims-Rose Scholarship Fund was established on April 23, 2002 with a contribution from Pamela C. and Kim M. Rose. The scholarships are awarded to students from Knox County pursuing a degree in elementary education.

Nancy L. Sinclair Scholarship Fund

The Nancy L. Sinclair Scholarship Fund was established on June 27, 2008 with various contributions from the family and friends of Nancy. Scholarships are awarded to students from Mount Vernon High School on the basis of demonstrated financial need and academic merit.

Harold W. Smith Family Scholarship Fund

The Harold W. Smith Family Scholarship Fund was established on July 6, 2012 from a bequest of Glenn E. Smith. Scholarships are awarded to graduates of Utica High School on the basis of financial need and academic achievement. Preferred candidates are those majoring in either business or agriculture and have completed at least one-half of the courses required for a bachelor's degree.

Dean and Audrey Spearman "Rollin' Buckeye" Scholarship Fund

The Dean and Audrey Spearman "Rollin' Buckeye" Scholarship Fund was established on December 28, 2000 with a contribution of \$26,500 from Dean and Audrey. Scholarships are awarded in order of preference to students attending: The Ohio State University majoring in education; The Ohio State University regardless of major; any Ohio state-supported university majoring in education; any Ohio state-supported regardless of major; and any undergraduate at an Ohio college or university majoring in education.

Stephanie Thompson Sprang Memorial Scholarship Fund

The Stephanie Thompson Sprang Memorial Scholarship Fund provides scholarships to female Mount Vernon graduates based on merit and need. Scholarships are recommended by the Mount Vernon High School Guidance Office.

Strang Memorial Scholarship Fund

The Strang Memorial Scholarship Fund was created in 1995 via a \$20,000 testamentary gift from Irene B. Strang. Scholarships benefit graduating seniors of Mount Vernon High School.

The Student Scholarship Fund

The Student Scholarship Fund was created on June 19, 1964 with an anonymous \$500 gift. The scholarship is for use of the general scholarship fund.

Ulery Knox County Career Center Scholarship Fund

The Ulery Knox County Career Center Scholarship Fund was established on June 5, 2018 by Carol Ulery in memory of William Ulery, owner and operator of Strang Glass for over 60 years in Mount Vernon. The fund provides scholarships to Knox County Career Center students to further their education at an accredited vocational, trade, or technical school. Academic merit is not to be considered, but does consider financial need. Preference is given to students planning to learn non-office/administrative based trades such as carpentry, construction, industrial, utility, machine operation and/or repair. Scholarships are renewable for one additional year subject to student demonstrating they are actively progressing towards a degree or certificate & plan to continue their training for a second year.

Utica Class of 1956 Scholarship Fund

The Utica Class of 1956 Scholarship Fund was created on February 1, 2006 with a contribution of \$10,930. Scholarships are awarded to a graduating senior from Utica High School who has attended Utica High School for the last three years of high school, maintained a 3.0 gpa, and displays a good work regimen and shows desire to improve himself/herself based on the junior and senior years of high school. The applicant shall provide a one-page statement that describes why he/she has chosen to pursue a specific area of study. A letter of recommendation is required from a faculty member and a community member (not related to the applicant).

John and Nancy Wagner Family Scholarship Fund

The John and Nancy Wagner Family Scholarship Fund was created on December 31, 2015 with contributions of \$20,116.08 made in honor of their parents by Elizabeth A. Wagner (Hults) and Sarah E. Wagner, and a matching \$10,058.04 grant from the Ariel New Philanthropy Fund. The fund awards scholarships to graduating seniors of Mount Vernon High School and Fredericktown High School based on academic merit and/or demonstrated financial need.

LouAnne and Gerald Walker Science Scholarship Fund

The LouAnne and Gerald Walker Science Scholarship Fund was created by their daughter, Claudia Grove, on June 24, 2013 with contributions made as a memorial to Gerald "Gus" Walker. The fund provides scholarships for students of any high school in Knox County, regardless of a student's residency, pursuing the study of science. Scholarships are awarded based on academic merit.

Carlos E. and Celestine A. Watkins Scholarship Fund

The Carlos E. Watkins First-Knox Scholarship Fund was created on November 9, 2006 with a contribution of \$400,000 from Carlos. Scholarships are awarded to children of First-Knox National Bank and Farmers & Savings Bank employees who have been an employee for at least 18 months prior to the scholarship application deadline and averaging at least 20 hours per week, regardless of high school attended. Awards are based on financial need and academic merit and meeting other eligibility requirements.

Vaughn Wiester Music Scholarship Fund

The Vaughn Wiester Music Scholarship Fund was established on November 10, 2010. Scholarships are provided to any graduating high school senior residing in Knox County, who intends to continue the study of music at the college level. Preference given to applicants who will declare an academic major, or minor, in instrumental or vocal music; however, consideration will also be given to non-music majors or minors, who will combine some academic study of music at college with continued extracurricular performance of music. Applicants need to submit a one-page letter summarizing their musical performance experience to date, and state their intentions for post-secondary music education. A letter of recommendation from a faculty member, or from a private music instructor, may be attached to letters of application, if desired. Letters of application and letters of recommendation should be postmarked, or hand-delivered to the Knox County Foundation by the deadline, along with an audio CD (mp3 or other popular format) containing two to three minutes of solo vocal or instrumental performance (or ensemble performance, if the applicant's performance is clearly discernible), preceded by a descriptive audio introduction of the student and the performance setting (Due April 15th).

Jay M. and Sarah L. Wilson OSU Scholarship Fund

The Jay M. and Sarah L. Wilson OSU Scholarship Fund was created on November 16, 2000 with a \$10,000 contribution from Jay and Sarah. Scholarships are awarded to graduates of any public high school in Knox County who is enrolled at the main campus of The Ohio State University.

William E. Wing Music Scholarship Fund

The William E. Wing Music Scholarship Fund was created October 16, 1990 through a \$10,000 testamentary gift under the will of Audrey F. Wing. The fund provides scholarships to graduating seniors from Mount Vernon High School furthering his/her education in music. Scholarships are recommended by the music department at MVHS.

Ralph W. and Gertrude E. Workman Scholarship Fund

The Ralph W. and Gertrude E. Workman Scholarship Fund was created on December 30, 2015 through a \$10,000 testamentary gift under the will of Gertrude. Scholarships are awarded to graduates of Fredericktown High School enrolled in a college in Ohio. Academic merit and financial need are considered equally when awarding.

Charles M. Zelkowitz Community Service Award

The Charles M. Zelkowitz Community Service Award was established on September 4, 1973 with \$5,000 in various contributions in the memory of Charles. Scholarship recipients are selected by the Foundation Board, based upon nominations from Knox County high schools, to a student who has performed significant community service, either through school or non-school activities.

Helen E. and Charles M. Zelkowitz Scholarship Fund

The Helen E. and Charles M. Zelkowitz Scholarship Fund was established on December 31, 1969 when Mr. and Mrs. Zelkowitz deeded a building in Fredericktown to the Foundation. Scholarships are awarded to students who most strongly display leadership initiative. The Knox County Career Center Superintendent recommends recipients.

Stephen W. Zelkowitz Ethics Scholarship Fund

The Stephen W. Zelkowitz Ethics Scholarship Fund was established May 19, 1993 with a \$10,000 contribution from Helen E. Zelkowitz. Recipients are selected by the Foundation Board, based upon nominations from the principal, guidance counselor or teachers of Mount Vernon High School and the Knox County Career Center. Nominees must demonstrate high ethical standards both in school and non-school related activities, demonstrate financial need, and have proven academic achievement.

Gloria Ahl Early Childhood Education Scholarship

This one-year scholarship was established in 2018 by the family of Gloria Ahl, an elementary school teacher of 25 years, primarily in Mount Vernon. It provides a one-year scholarship in 2019 to a graduating senior of Mount Vernon High School pursing a degree in early childhood education.

Centerburg High School Alumni Scholarship Fund

The Centerburg High School Alumni Scholarships are provided by various donors for seniors attending Centerburg High School. Scholarships are given to students recommended by the Centerburg High School Alumni Association, according to criteria the Association may establish and revise from time to time. Scholarship recipients will be required to attend the CHS Alumni Association Annual Banquet to accept your scholarship check and possibly read your essay before the alumni. The banquet is held each year on the Saturday evening of Memorial Day weekend.

The Robert S. & Carol Jo Gregg Family Scholarship Fund

The Robert S. & Carol Jo Gregg Family Scholarship Fund is given through the Robert S. & Carol Jo Gregg Family Donor Advised Fund and was established on December 31, 2018 by Robert S. Gregg. The

scholarship is awarded to a graduating Knox County High School Senior with at least a 3.0 GPA and who has participated in at least one of the following: Two years of FFA or four years of 4-H.
